PRESIDENT'S MESSAGE Central Dentists Give More

I recently wrote a narrative about the obligation of dentists to stay active in organizations that support and promote dentistry as an industry. Now, I want to expand on that narrative and suggest that not only do we have an imperative to protect our profession, we have a moral obligation to ensure our profession continues to protect the best interests of the people we serve. Recently, a prominent

political figure and our surgeon general both spoke on the misguided "dangers" of community water fluoridation. It is not the purpose of this commentary to refute and verbally roll my eyes at this notion; rather, I would like to take the opportunity to point out that dentists are truly special. It must be difficult for our opposition to explain why we as a profession fight for health policies that are financially outside our own best interests. Our brains function differently. We are special because at the end of the day ... we put the needs of our patients ahead of our own.

Remember your dental school interview and you were asked to describe why you wanted to be a dentist? I had the opportunity to be part of a dental school's admissions committee, and I can tell you with utmost confidence that not a single person responded with an overwhelming, lifelong desire to work in the oral cavity. Most of us have an innate desire to utilize our own two hands to help people. Despite the generalization, I have found this to be true year after year. There are obviously many ways to give back or contribute to society. Today I am going to talk about the Super Bowl of charitable dental opportunities — **The Florida Mission of Mercy**.

The Florida Mission of Mercy (FLA-MOM) is the signature program sponsored by the Florida Dental Association Foundation and is the largest charitable dental clinic in Florida that serves between 1,500 and 2,000 patients in one weekend a year. The dentists in Florida work together to provide free care to any patient, with the goal of serving the underserved and uninsured in Florida.

The 2025 event marks the **TENTH** event in the state and has provided over \$17 million dollars in care and treated over 15,000 patients in the last decade. In addition to statistics above, the FLA-MOM partners with Florida Veterans Foundation and other statewide/ local organizations that prioritize treatment for veterans. I am proud as president of the Central District to bring the FLA-MOM event back to Central Florida. I have the honor of being the co-chair of this year's Daytona Beach event with Dr. Bert Hughes. Dr. Hughes and I have combined almost 2 decades of experience organizing and participating with the Mission of Mercy since its inception. In addition, Central District dentists have donated their time, skill, and effort to help the program exceed year after year (despite the location in the State). We are STRONG as a component dental association and will continue to show patients that we give more than we take as a profession.

You will be shocked to find out that this event does not fund itself! Yes, that's right, we need your time and your skill, but we also need your money! The Florida Mission of Mercy needs our dentist to VOLUNTEER and DONATE to be successful. In November of 2024, the executive council of the Central District Dental Association proposed, voted and unanimously approved a resolution for the CFDDA to match any donations made to the FLA-MOM by Central District dentists up to \$20,000! In the last decade, the Central District has been the most charitable of any of the other component organizations and continues to raise the bar for other components to fund this heartfelt event.

Trustee Report

The Florida Dental Association (FDA) Board of Trustees convened at FDA headquarters in Tallahassee, December 6 and 7, 2024. The following are key issues that were discussed at the meeting:

2026 Florida Dental Convention: The Board approved the program for the 2026 Florida Dental Convention, showcasing the forward-thinking efforts of the Committee on Continuing Education and Conventions.

Communities of Interest: After evaluating the "Communities of Interest" initiative launched in 2023, the Board decided to discontinue the program due to limited engagement. In its place, several task forces have been created to address key areas such as membership, new dentists, and public health insurance. Focus groups will be organized to explore strategies for enhancing member engagement. Also, when issues arise that need to be addressed, the FDA President will create

task forces. One example is fluoridation. The topic has arisen quickly, and a task force can be created to discuss the issue and create solutions.

2025 ADA House of Delegates: Multiple openings for the 2025 17th District Delegation to the ADA House of Delegates were announced. Members are encouraged to consider running for these positions.

Member/Non-Member Survey: The Board received an update on the recent survey, which closed at the end of November. A final report will be available soon. Some pertinent results include participation rates comparing older dentists to younger. There is a higher percentage of older dentists that are members than younger dentists and they tend to participate more. This could be an issue for the FDA as the older members retire. Most respondents were at least somewhat satisfied with the FDA. Also, most were likely to renew membership. The most important reason to be a member according to existing members is advocacy and support for the profession. The most common reason for nonmembers not to join is cost compared to benefit. The Board approved conducting focus groups to explore topics like member communication preferences in greater depth.

Fluoride Update: Dr. Johnny Johnson delivered a presentation on fluoride issues, with reference to comments from Florida's Surgeon General. Members can find further details and a fact sheet on the FDA website at <u>www.floridadental.org</u>.

Central District Management Services: FDA Executive Director, Drew Eason, announced the Central District

leadership voted to have the FDA provide management services for the Central Florida District Dental Association (CFDDA) following Marlinda Fulton's departure in June 2025.

Editor Advisory Committee: In June 2024, the FDA House of Delegates passed a resolution asking the FDA Editor to review the position of editor and bring forward a resolution regarding a possible associate editor position. Dr. Wunderlich, the current FDA Editor, proposed creating an Editor Advisory Committee with one member from each component in order to offer exposure to tasks associated with the Editor position and to help create content. Ultimately, this will help develop replacements for the Editor when the term is completed.

RFDA Proposal: Six years ago, a rules change was made by the Florida Board of Dentistry to allow Restorative Function Dental Auxiliaries. With proper training, dental assistants and hygienists can place restorations (but not prepare) teeth. However, due to Covid, the issue was put on the back burner and has not been advanced. The FDA may create a didactic portion and also use hygiene schools when they are not in session to facilitate training.

Healthy Dentist Program: Larry Darnell, FDA Director of Strategic Initiatives and Technology, provided an update on the FDA Healthy Dentist program. Beginning in January, the Member Assistance Program will offer members and their families 24/7 access to professional counseling services. (See page 13.)

Public Affairs Update: The Board received an update from Moore, the FDA's public affairs consulting firm, on the FDA's social media campaign promoting the importance of seeing an FDA dentist. Moore also reviewed significant media coverage on fluoride and continues to support leadership and members with media interview preparation on key issues.

Florida Mission of Mercy: The FDA Foundation and Central Florida District Dental Association will host the 2025 Florida Mission of Mercy in Daytona Beach on March 21-22. The Co-Chairs are Joe Richardson and Bert Hughes. Volunteer registration and hotel registration is now open, so please visit FLAMOM.ORG to sign up.

Florida Wellness: The FDA is starting a wellness program for its members. Under this program a member will be afforded a limited number of free mental health sessions, with extended care at a reduced rate. These sessions will obviously offer anonymity to participants, and help dental professionals receive some of the care they need.

ADA President Elect Campaign: Due to the use of technology, fundraising and the contraction of travel by all the ADA President Elect Candidates, the FDA will receive a refund of the monies it collected for the ADA President Elect election.

FDA Services: The FDAS has had another banner year. It *(Continued on page 14)*

FLORIDA BOARD OF DENTISTRY REPORT Florida Board of Dentistry Meets in Gainesville FDA Chief Legal Officer Casey Stoutamire

The Florida Board of Dentistry (BOD) met in Gainesville on Friday, November 15, 2024.

The Florida Dental Association (FDA) was represented by BOD Liaison **Dr. Steve Hochfelder** and Chief Legal Officer Casey Stoutamire. FDA Executive Director, Drew Eason, FDA Lobbyist, Brandon Edmonston and FDA Trustee, Dr. Bertram Hughes, were also in attendance. **Dr. Jim Haddix** and students from the University of Florida College of Dentistry and the Santa Fe Dental Hygiene and Assisting programs also attended.

BOD members present included: **Dr. Jose Mellado**, chair; **Dr. Nick White**, vice chair; **Dr. Claudio Miro**; hygiene members, Ms. Karyn Hill and Ms. Angela Johnson; and consumer members, Mr. Fabio Andrade and Mr. Ben Mirza. **Drs. Brad Cherry** and **Tom McCawley** were absent but excused. There are two open dental positions on the board. Unfortunately, this was Mr. Andrade's last meeting as he was elected to the Weston City Commission, which means there is also an open consumer position on the Board. The FDA thanks Mr. Andrade for his service and wishes him good luck in his future endeavors! This was also the first meeting for the new board executive director, Ms. Traci Zeh and the FDA looks forward to working with her.

The board approved updates to the licensure applications for those applicants applying for licensure with scores from the American Board of Dental Examiners (ADEX) licensure exam taken after October 1, 2011, which is when Florida moved away from a state licensure exam and started accepting the ADEX exam. As part of the application process, a dentist must show that they have been engaged in the full-time practice of dentistry in the state from which they are transferring. This update modifies how an applicant shows and how the board verifies the full-time practice requirement. As a reminder, this was the language the FDA and BOD staff worked on several years ago and that the legislature approved the last session.

During the August meeting, the board heard a request for a declaratory statement. The petitioner asked the board to clarify that a dentist with a health access dental license practicing within a health access setting includes the programs of the health access setting (as defined in Ch. 466.003(15)) and is not limited to practicing within a brick-and-mortar building of the health access setting. The board directed the board counsel to draft a statement that statutory language includes programs a health access setting provides in other locations and is not limited to a brick-andmortar building. The health access setting license is tied to the particular setting/program and not a physical location. The board counsel brought the actual verbiage of the statement back to the board at this meeting, and it approved the declaratory statement.

During the report from the Council on Dental Hygiene, the board approved the proposed revision to the rule on Required Sterilization and Disinfection Procedures so that it complies with OSHA and CDC guidelines. The rule, which is not yet effective and working through the rulemaking process, will now read:

64B5-25.003 Required Sterilization and Disinfection Procedures

1(a-f) no change

(2)(a) Surgical and other instruments that normally penetrate soft tissue or bone, including, but not limited to, forceps, scalpels, bone chisels, scalers, and surgical burs, must be sterilized after each use.

(b) Instruments that are not intended to penetrate oral soft tissue or bone, including, but not limited to, high speed dental handpieces, <u>slow-speed handpieces</u>, <u>slow-speed</u> <u>motors</u>, <u>air-polisher nozzles</u>, <u>air-polisher body</u>, contraangles, <u>reusable</u> prophy angles, amalgam condensers, plastic instruments, and burs, but that may come into contact with oral tissues must be sterilized after each use according to the manufacturer's instructions for use.

(c) However, if heat, steam under pressure, or chemical vapor sterilization of an instrument is not technically feasible, due to its size or composition, the instrument must undergo sterilization with a disinfectant/sterilant that destroys viruses and spores. Disinfectants must be registered by the U.S. Environmental Protection Agency (EPA) as a disinfectant/sterilant and must be used in accordance with the manufacturer's recommendations and in accordance with CDC Guidelines as defined and incorporated by reference in subsection 64B5-25.002(4), F.A.C.

(d) High speed dental handpieces, <u>slow-speed dental</u> <u>handpieces</u>, <u>slow-speed motors</u>, <u>air-polisher nozzles</u>, <u>air-polisher body</u>, slow speed dental sleeves, <u>and</u> contra-angles, <u>and reusable</u> prophy angles must be sterilized after each use using a heat or heat with pressure or heat with chemical method. The method used must be capable of sterilization

In August, the board approved rules to implement SB 1600, licensure by endorsement. As a reminder, to be eligible for licensure by this method, a dentist will have to qualify based on all the requirements in the statute, which include practicing dentistry three of the previous four years before application, having no disciplinary history and not having any information reported to the National Practitioner Databank, passing a national licensure exam (this does not include a state-specific licensure exam) and passing the Florida Laws and Rules exam. Unfortunately, the statute does not require an applicant to graduate from a CODA-approved dental school, and since there is no statutory authority, the board could not promulgate a rule requiring this. However, the FDA *(Continued on page 14)*



continues to return profits to help keep members dues low. The agency was not adversely impacted by the storms and should be able to return a healthy donation to the FDA. Currently, it is writing 25% of its business outside of Florida.

Dental Volunteers needed: There are a number of areas where volunteers are needed. These include the Board of Dentistry, including a consumer position, FDA Audit committee and the aforementioned Editor Advisory committee.

Hygiene Handpiece Sterilization: The Board of Dentistry codified the rule to require sterilization of the entire hygiene handpiece, including the motor. This is in congruence with the CDC rule pertaining to hygiene handpieces.

Non-Dues Revenue Investment: The FDA Board has entered into an agreement with a Dental Investment group to gain access to private equity investment to help with the diversity of the FDA investment portfolio. This will help improve gains and increase the availability of non-dues revenue.

plans to pursue legislation to resolve this issue during the 2025 legislative session. At this meeting, an attorney asked the board to consider defining the practice of dentistry to include years in residency. Thus, an applicant could use the previous years of residency to fulfill the practice requirement when applying under the MOBILE Act. The board counsel's opinion is that no rules are needed on this topic and the board can take this up on a case-by-case basis. However, based on the board's information discussion, it does not appear likely that this current board would include time in a residency in the definition of full-time practice of dentistry.

There were six disciplinary cases and one determination of waiver that included, among other things, incorrect implant placement, record-keeping violations and endodontic treatment. A theme in all of the cases was the need for proper communication between the dentist and the patient.

Finally, Dr. White was elected chair and Dr. Miro was elected vice chair for 2025. The FDA thanks Dr. Mellado for his service as chair and looks forward to working with Dr. White in the upcoming year. Also, during his chairman's report, Dr. Mellado thanked the FDA representatives in the room. He mentioned he had recently received his American Dental Association Life Member pin and encouraged everyone to join organized dentistry.

It is much better to be a spectator than a participant in BOD disciplinary cases. The next BOD meeting is scheduled for Friday, February 14, 2025 in West Palm Beach.


